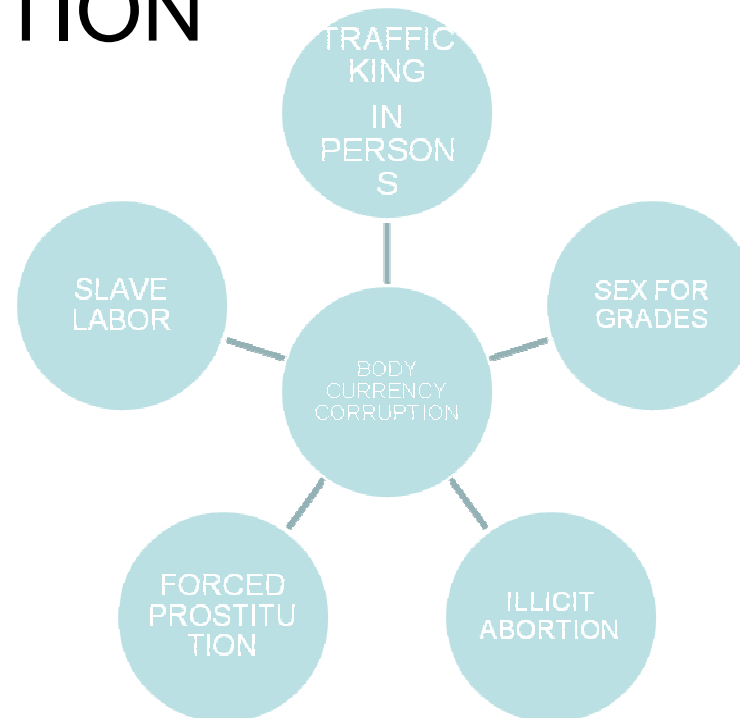

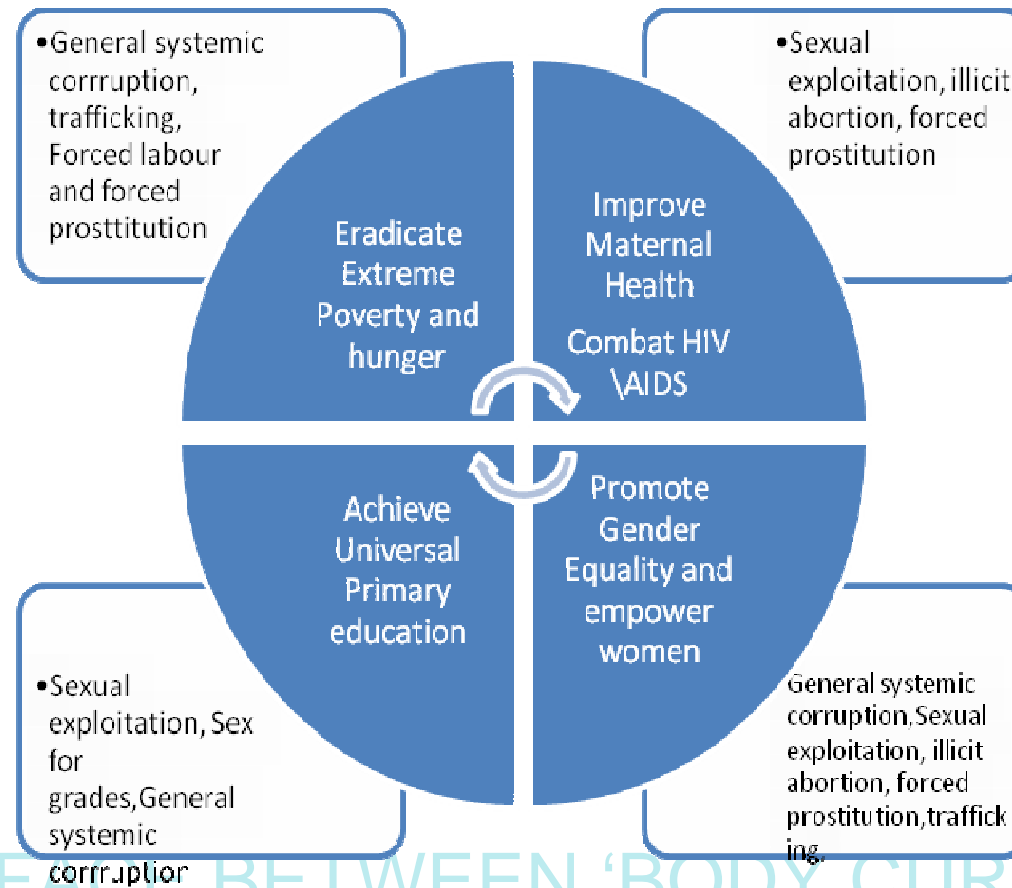
## Millennium Development Goals
